# Welcome to the 2017 edition of the "Mississippi State Fair Antique Vehicle Exhibition"

It is our goal that when you leave the exhibition you will have had a very pleasant and enjoyable experience. It is also hoped that the Board of Directors of the Antique Vehicle Club of Mississippi will feel the same way. There are very few rules that actually govern the manner in which the exhibition is presented. We do feel that it is important to advise you of these guidelines.

- All entries must be antique, unmodified transportation vehicles, model year 1980 or older other than any specific vehicle that has been in a previous Mississippi State Fair Car Show which itself only will not be disqualified for reason of age.
- <u>PROOF</u> of insurance and a fire extinguisher are required for each vehicle and will be verified before the vehicle is admitted. <u>NO</u> exceptions!!!
- The AVCM is dedicated to the preservation and restoration of antique vehicles. Vehicles that are radically different from original will not be accepted into the exhibition. Any questions regarding this issue will be resolved before the vehicle is accepted.
- Disconnect the vehicle's battery!!! Leave the vehicle unlocked. Place the keys under the floor mat or in the ashtray or glove box.
- Place a mat under the vehicle to catch drips. <u>YOU</u> are responsible for cleaning the floor under your vehicle before you leave. Please do your part to help us.
- No advertising signs allowed with the vehicle. Please use the bulletin board for all business cards, "For Sale" or similar signs. Also, no trophies from previous shows of any kind are allowed with the vehicle.
- Please have your vehicle ready for judging on Saturday morning October 14th. Your vehicle must be unlocked with the hood open before the judges arrive.
- <u>NO</u> vehicles will be removed from the exhibition hall once in place, until 3:00 P.M. on Sunday October 15<sup>th</sup>. NO exceptions!!!
