EXHIBITION RULES AND LIABILITY RELEASE

It is our goal that when you leave the exhibition you will have had a very pleasant and enjoyable experience. It is also hoped that the Board of Directors of the Antique Vehicle Club of Mississippi (AVCM) will feel the same way. There are a few rules that govern the manner in which the exhibition is presented. We feel that it is important to advise you of these guidelines and appreciate your cooperation.

- **All entries must be antique, unmodified transportation vehicles, model year 1980 or older.**
- **Proof of insurance and a fire extinguisher are required for each vehicle and will be verified before the vehicle is admitted. No exceptions!!!**
- **The AVCM is dedicated to the restoration, maintenance and preservation of antique vehicles. Vehicles that are radically different from original will not be accepted into the exhibition. Any questions regarding this issue will be resolved before the vehicle is accepted.**
- **You MUST disconnect the vehicle's battery when the vehicle is parked! The Fire Marshall requires that each vehicle battery be disconnected for fire safety. Please see that this is done on the first day.**
- **Leave the vehicle unlocked. Place the keys under the driver's floor mat.**
- **Place a mat or plastic bag under the vehicle to catch drips. YOU are responsible for cleaning the floor under your vehicle before you leave. Please do your part!**
- **No advertising signs allowed with the vehicle. Please use the bulletin board for all business cards, "For Sale" or similar signs. No trophies from previous shows of any kind are allowed with the vehicle.**
- **Note Change: Please have your vehicle ready for judging the morning of the FIRST Saturday of the exhibition. Your vehicle must be unlocked with the hood open before the judges arrive. Judges will not be responsible for opening hoods prior to judging; therefore, points will be deducted. Otherwise, please advise us that your vehicle is for "Display Only".**
- **NOTE CHANGE: All vehicles must be checked in on TUESDAY prior to the Fair opening on THURSDAY. NO EXCEPTIONS. The TradeMart will be locked with Security until Fair opens Thursday.**
- **Note Change: Absolutely NO vehicles will be cranked during or removed from the exhibition hall for any reason once in place until the close of the exhibition and the approved removal day. Vehicle removal will be on Monday after Sunday's close of the Fair.**

Liability Release: I understand and agree that the Antique Vehicle Club of Mississippi and the Mississippi Fair Commission will not be responsible for any liability that might occur during this event. I further agree to abide by all rules and regulations of the Antique Vehicle Club of Mississippi and the Mississippi Fair Commission.

Volunteer Commitment Form

Due to the success of our show each year at the State Fair and the large number of Fair-Goers who enjoy and visit our show, we need help from our vehicle owners to oversee our vehicles during the Fair show. We do not want to leave the vehicles unattended at any time the Trade Mart is open to the public, and it takes a large number of volunteers to accomplish this task.

All vehicles participating in the car show will be given one free gate pass to the Fair. If you help man the show for at least two pre-scheduled shifts during the Fair, we will provide you with one additional pass to the Fair. This is a total of two passes if you enter a car and volunteer to help watch and protect our vehicles. Each pass provides free entry for one person and one vehicle.

The Fair and TradeMart typically opens Thursday at 5 pm with the TradeMart open daily, 10 am through 8 pm, Monday through Sunday until the last day. On a rare occasion the TradeMart management will change hours with notice.

Please indicate below the days and hours you will volunteer so we can insure we have enough individuals to oversee the vehicles during the time the Trade Mart is open. We need volunteers to cover 3 shifts each day of the Fair. Please volunteer for as many shifts as possible.
